Those standards require that we plan and perform the examination to obtain reasonable assurance about whether management's assertion is fairly stated, in all material respects. An examination involves performing procedures to obtain evidence about management's assertion. The nature, timing and extent of the procedures selected depend on our judgment, including an assessment of the risks of material misstatement of management's assertion, whether due to fraud or error. We believe that the evidence we obtained is sufficient and appropriate to provide a reasonable basis for our opinion.

We are required to be independent and to meet our other ethical responsibilities in accordance with relevant ethical requirements relating to the engagement.

As required by MPS Minimum Audit Requirements, a representation letter is attached representing that management of the Charter is responsible for compliance with contractual requirements.

In our opinion, management's assertions that the Charter complied with the aforementioned requirements for the school year ended June 30, 2023 is fairly stated in all material respects except for requirements in relation to the Calendar submission, immunizations, mid-year unaudited financial statement submission, budget submission, board of directors list submission and correction of prior audit material weaknesses as stated in the attached summary schedule.

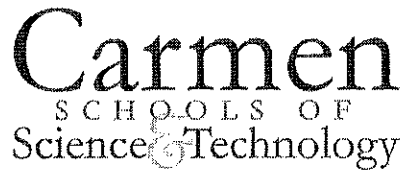

- 1** Section I.F. of the contract states that the charter school shall provide a list of the names of the individuals serving on the governing body of the Charter to MPS and that the Charter shall be responsible for notifying MPS whenever the membership of the governing body of the charter changes; however, submission to MPS did not include one member of the governing body.
- 2** Section I.H. of the contract states that the charter school shall ensure that all of its pupils comply with Wisconsin immunization requirements. According to the Health Immunization Report, the Southeast location was 98.5% compliant, the South location was 99.7% compliant, the Northwest Middle location was 96.3% compliant and the Northwest High location was 97.4% compliant.
- 3** Not applicable - This language is not contained in the Charter's contract.
- 4** Not applicable - Requirements or notifications to MPS do not apply in the current year.
- 5** Section I.K. of the contract states that the charter school shall submit mid-year unaudited financial statements by February 15, 2023; the Charter received an extension until March 7, 2023. The Charter did not submit their mid-year unaudited financial statements until May 12, 2023.
- 6** Section I.K. of the contract states that the charter school shall address or correct for findings or material weaknesses addressed in the single audit report or management letter. The Charter school had a repeat finding for adjusting journal entries.
- 7** Not applicable - The Charter does not provide transportation.
